Obligations of Alongside Ministries Inc

For the duration of the twelve month contract period Alongside Ministries Inc agrees to provide:

- 1. a mentor who will meet with the designated pastor for at least six one hour sessions
- 2. a 50% discount on registration fees for Alongside Ministries seminars
- 3. a 50% discount on Alongside Ministries resources including training DVDs, publications etc
- 4. a pro-rata refund of care package fees in the event that Alongside Ministries is not able to provide the services offered in this contract.
- 5. a sixty minute training seminar for church leaders, dealing with care and supervision of pastors.
- 6. an information pack for pastors and Christian workers. This pack includes a list of recommended Christian counselors as well as doctors willing to provide bulk-billed medical checkups.

Obligations of the church providing the care package

For the duration of the twelve month contract period the church providing the care package agrees to:

- 1. make full payment for the package within 30 days of commencement of the contract period.
- 2. allow the pastor release from pastoral duties to attend mentoring sessions and training seminars.
- 3. respect the confidentiality of all aspects of the mentoring process.
- 4. provide opportunity for a 60 minute training seminar with church leaders, dealing with care and supervision of pastors (optional).

Obligations of the pastor receiving the care package

For the duration of the twelve month contract period the pastor receiving the care package agrees to:

- 1. attend all planned mentoring sessions and make every effort to provide forty-eight hours notice of inability to attend. (At the initial meeting, dates will be determined for the remainder of the contract period. At the discretion of Alongside Ministries, in the event that a pastor fails to attend a mentoring session without 48 hours prior notice, the session will be counted as one of the eight contracted sessions.)
- 2. maintain honesty in all interaction with his/her designated mentor.
- 3. make every effort to obtain maximum benefit from the mentoring process.

Pastor/Mentor Confidentiality

Except where prohibited by law an Alongside Ministries mentor shall maintain confidentiality with respect to information supplied by a pastor during the mentoring process. This confidentiality shall extend indefinitely beyond the period of the care package contract. With the pastor's written permission the mentor may be given freedom to discuss the pastor's situation with an agreed person of group in the context of providing appropriate pastoral supervision/care.
